ORBIT INTERNATIONAL CORP. POWER UNIT SEGMENT
RECEIVES \$500,000 IN NEW MILITARY ORDERS

Hauppauge, New York, July 9, 2002—Orbit International Corp. (NASDAQ:ORBT) today announced that its Power Unit Segment, Behlman Electronics, Inc., has received new orders for approximately \$500,000. Deliveries under these contracts are expected in the second and third quarter of 2003.

The Company received an order for approximately \$300,000 from the U.S. Navy Aviation Supply Department for a display power supply to be used on the E2C Hawkeye aircraft. The E2C Hawkeye is an integral component of the Navy's carrier air wing providing all-weather airborne early warning command control functions. The E2C provides these functions to aircraft such as the F-14 Tomcat and the F/A-18 Hornet and works closely with AEGIS Naval Ships to provide total air superiority over the Naval Fleet.

In addition, the Company received an order for approximately \$200,000 for additional F/A-18 Roll Resolvers. This order is in addition to the \$1,000,000 order received in August 2001 and this new contract also contains an option for the purchase of additional units totaling approximately \$200,000.

Dennis Sunshine, President and CEO of Orbit commented, "We are proud that Behlman power supplies can now be found on many mission critical aircraft and ships in the Naval Fleet. In the past 12 months, Behlman has received orders in excess of \$5,000,000 in support of these two programs. Furthermore, we expect continued revenue from the sale of our products for both the F/A-18 and E2C programs in the coming years. We are pleased with the continued growth of Behlman's custom division and remain confident that Behlman's high quality cost effective power solutions will continue to generate new business opportunities for our Company".

Orbit International Corp., based in Hauppauge, New York, is involved in the manufacture of customized electronic components and subsystems for military and nonmilitary government applications. Its Behlman Electronics, Inc. subsidiary manufactures and sells high quality commercial power units and low noise uninterruptable power supplies (UPS). The Behlman custom division designs, manufactures and sells power units and electronic products for measurement and display.
